Connectional Lay Organization 33rd Biennial Session

Hundreds of lay persons from around the Connection arrived in Atlanta, GA, on July 27 & 28 for the 33rd Biennial Session of the Connectional Lay Organization.

The Opening Worship Service was held on Sunday, July 28. Most of the Bishops joined their colleague, Bishop William P. DeVeaux, Sr., Chairperson of the Lay Commission, in attending the Service. The Senior Bishop of the AME Church and our Bishop, Bishop John, was the preacher. The subject of his message was "We Have Got to Give Jesus Our Best" with scripture reference Matthew 26:6-13. Holy Communion was served after the sermon.

The official opening of the 33rd Biennial Session was Monday morning, July 29. 1,042 registered delegates were in attendance. President Dr. Willie C. Glover delivered his presidential address. His stewardship report was reflective of his leadership. A highlight of the opening day was the Election of Biennial Officers (election results are on page 14).

Training consisted of two Plenary Sessions and three workshops. The Plenary topics were "Lay/Clergy Partnerships" and "Intergenerational Leadership". Each featured panelists of both clergy, including Bishops, and laity.

Fourth District YAR Michael Cousin participated on the panel discussing lay/clergy partnerships. He did an excellent job sharing his thoughts on how the laity and clergy can more effectively work together.

Titles of the workshops were, "What Does it Take to Grow", "Christian Lay Leaders" and "Finance: Handling God's Money, God's Way". Several clergy and laity presented the workshops. The topics were appropriate for growth and created lively discussions.

At the Fourth District Luncheon,

we were able to applaud our newly elected Chaplain, Alice Belden. She thanked us for supporting her and shared her outlook for her role as CLO Chaplain. We were blessed to have Bishop John, Rev. C, and 4th District Lay Organization Media Sponsor, PE Hughes, attending the luncheon.

They were both acknowledged for the outstanding work they have done throughout the AME Church. Journalist Roland Martin was the keynote speaker, and the African/ Caribbean delegation entertained us with their touching dance and song. Three \$5,000 scholarships were awarded to students in the 7th. 10th and 18th Districts. Four \$500 book awards were also presented, and Hans Isaac Peddiny from the India Conference was the recipient of one of these awards.

All Committees gave reports reflective of the work that is being done throughout the Connection. Some Committee work is ongoing and members will continue to work.

The 34th Biennial Session of the Connectional Lay Organization will be held in the Seventh Episcopal District. President Roger Cleckley and the delegates from the Seventh District made an inviting presentation showing a video of what South Carolina has to offer. The 33rd Biennial Session concluded with the Installation Service for new officers. Bishop McKinley Young performed the installation. •

The Theodore Harris Lay Leadership of the Fourth Episcopal District is established to prepare members of the Lay Organization, ages 18 to 40 years, to assume leadership roles at all levels of the African Methodist Episcopal Church, specifically within the Lay Organization. This model has been adapted from several other Lay and Missionary Leadership Institutes and is established in the memory of Mr. Theodore E. Harris, a former member of St. Paul AME Church (downtown) in Detroit, Michigan. This plan was approved by the 4th Episcopal District Lay Organization Executive Board in March 2013.

The vision is to build a strong culture of lay leaders, who practice a unifying leadership style, which builds oneness in an organization. This will be done through educational, practical and mentoring experiences. The period of training and mentoring is from the District Convention 2013 to the District Convention 2014. 20 young adults and 20 mentors (lay leaders) are the target group.

Theodore E. Harris was an active member of the AME Church for over 40 years. He served as a member of the Steward Board, President of the Lay Organization and a member of the Stewardship and Finance Commission. Ted was also a leader in the Connectional AME Church, where he served as a delegate to several General Conferences, Lay Biennial Conventions and a member of the AME Church General Board.
